

4. **RECEIPT OF REPORTS**
Reports from the County Councillor, District Councillor, Chair of Council, Chair of Environment and Amenities Committee, Year End Accounts and Precept, and a number of village organisations had been circulated with the agenda pack prior to the meeting on the website and hardcopy made available to anyone on request.

Chair asked the County Councillor if she had anything further to report and invited questions from those present. County Councillor Harford thanked the Councillors and Clerk for all their work. She was sorry the Council would be losing the Clerk. She thanked the Chair and made special tribute to all those involved in helping during the Covid-19 pandemic – Bar Hill was a great village and she was very happy to be the County Council representative. He reiterated the main points and explained some of the problems with the taking over and implementation of the new contract. He gave thanks on behalf of the village to Dr Rasool who had been at the Maple Surgery for 7 years.

Concern was expressed that patients were having to stand outside to wait to be called in to see medical attendants. It was understood screens were to be installed so that people could go inside now that Autumn and Winter were upon us.

Chair invited the Girl Guide leader to speak, who apologised for not having got a report submitted in time for circulation. She said they had 87 girls, ranging from 5 years to 15 years and they were meeting by Zoom. Some had left but others joined and were enjoying the Zoom sessions.

Cambridgeshire County Councillor's Report **Annual Parish Meetings - Bar Hill Division**

The last year has been extremely challenging for us all. We have experienced a way of life that none of us could have imagined beforehand. There has been so much loss for so many: income, livelihood, time with family and friends and most sad of all, the loss of lives. Throughout the year those working in key roles continued to provide essential services and support, and I know that we are all grateful to all those employed in the health and care sector, teachers and support staff, the emergency services, those working in essential retail and the manufacturing and warehouse staff and drivers who kept those and other essential outlets supplied.

Local authority staff, too played their part. The county council was the recipient of the majority of the government's support grant and was responsible for the 'shielded' cohort of residents – making initial contact with them and offering a range of support. The model of wider support and working with local volunteers that developed, varied from district to district but all were similar in that there was no conflict or vying for control. Whatever worked best was the order of the day and the county council passed on the funding accordingly. Many staff from across the county council were redeployed to undertake essential support roles, some taking on very different roles to those they normally had. Two warehouses were set up on Alconbury Weald thanks to the generosity of the developer at that site and with the Red Cross stepping in to staff them. These held emergency food supplies, household goods, emergency stocks of PPE for care homes, testing kits etc. That arrangement has just ended after 12 months.

Locally each village set up its own support network according to what best served local needs, and communities did all they could to provide practical help as well as keeping each other's spirits up. When unexpected challenges presented themselves, the local community responded. Well done to every one of you who helped in that effort.

Now with the amazing success of the vaccination programme, restrictions on our way of life are beginning to be eased. The gradual relaxation of the lockdown rules is such welcome news and reflects the hard work that the vast majority of people put in during lockdown to allow us to reach this point. To ensure that we don't squander all that effort, everyone is being urged to continue to stick to the rules that are in place and to follow the 'hands, face, space and fresh air' guidance.

We know that having to focus so much effort on caring for Covid-19 patients meant less resource being available for other NHS services. Efforts are now being made to address the backlogs that have been caused as a result. Transformation of the way that the NHS works is taking place even as it recovers from the pandemic, in an effort to capture some of the improved ways of working that have resulted from its experience of working under such sustained pressure.

Whilst changes may be coming to the way Public Health is managed, at the moment the county council still has that responsibility. Efficiencies have been delivered and good practice shared through the creation of a joint public health directorate across both Cambridgeshire County and Peterborough City councils. Joint commissioning of

public health programmes, and partnership working across both authorities and with local NHS commissioners are footsteps on the path to the government's Integrated Care System strategy. In its public health role the county council continues to play an integral part in the management of Covid-19 outbreaks and infection control.

Similar to the NHS, some county council services have been affected by the pandemic.

Registration Service [Births, deaths and marriages] has experienced a difficult twelve months. When civil wedding ceremonies had to be postponed, the council refunded fees, despite having incurred costs itself. Pre-pandemic, work was underway for this service to become much more customer-focused and that will continue.

Coroners' Service has seen a significant increase in resources to ensure the quickest possible recovery.

Changes to the **Library Service** have continued in the last year and it is now positioned at the heart of the council's community service delivery model. Two mobile vans have just been replaced by new vehicles to allow the service to become more holistic - particularly with social mobility in mind. Whilst this work has inevitably been delayed by the pandemic, it will progress at pace following the reopening of libraries. A new central warehouse/operating hub has recently been purchased near St Ives and will open shortly. During the pandemic, the on-line and 'select and collect' services were greatly appreciated by many.

Adult Social Care

Looking to the future and trying to anticipate what the world may look like post pandemic, one thing seems clear. There will be rising demand on adults' services with an increasing complexity in needs. The decades old unresolved national issue of how to fund social care doesn't appear to be anywhere nearer to being resolved and firm proposals from the government are still awaited.

In recent years Cambridgeshire has been particularly successful at investing in prevention but it remains to be seen if there will be the same level of opportunities in the future, to continue this very worthwhile work. It is surely to the benefit of all of us as we age, to be able to maintain a good quality of life, and to continue to be able to live independently. Personal investment in our own health is crucial to that. As a member of Health committee, I have supported the investment made from the public health budget to support work on preventing falls [a major cause of health deterioration in the older age group] and health checks for the over forties.

More recently I have been a member of a working group of councillors monitoring the council's progress on a strategy to invest in Care Suites. This concept provides independent living and the opportunity to access care at the appropriate level for each individual according to the progress of their needs.

Education

Teachers and school support staff worked throughout the pandemic as schools remained open for the children of key workers and those considered vulnerable. At the same time teachers were also managing remote lessons to support home learning during lockdown.

Despite central government investment which provided around 4,500 laptops to children in need, research showed that around 8,000 children and young people across Cambridgeshire & Peterborough were being severely disadvantaged because they did not have access to the IT equipment or broadband they needed. The education service set itself a target to address this, both through working in partnership to refurbish donated devices and by raising funds to buy additional equipment.

The council used the initial £2.1m it received from the government as Winter Support grant to provide £15 of food vouchers to every eligible child both over the Christmas holidays and the February half term. Cambridgeshire subsequently received a further £507k which was used to extend the offer to the Easter holidays. A further announcement sees the grant renamed as Covid Local Support grant but looks to provide further funding which the council will augment to ensure that vouchers can be offered for the summer half term.

The return to school brought new challenges with schools now managing testing regimes in order to continue to contain the spread of Covid-19. Teachers also now face the challenge of helping children get back to a uniform level of learning. The DfE has recently published guidance for secondary schools on plans for summer schools. Secondary schools are being asked to sign up to run summer schools. The government continues to encourage schools to consider summer school provision, primarily for pupils making the transition into Year 7. Schools will though have the flexibility to target the funding to whoever they think could benefit most.

Highways & Transport

Having seen the opening of the upgraded A14 the previous year, this last year has seen a torturous negotiating process between Highways England [HE] and the county council as the former seeks to hand over to the latter sections of old, de-trunked road and various items of new infrastructure. Having refused responsibility for restoration of the local roads that suffered through diversions and increased traffic volumes during the project, HE has supported a bid to government for additional funds to enable the council to do the work. The Bar Hill roundabout and the road through Dry Drayton were both included in the original list for restoration work and remain priorities for allocation of any funding that is secured for this purpose.

The development consent order for improvement works to the A428 was very recently submitted and accepted for examination by the planning inspectorate. County council officers are preparing to review the documents and an intensive period of work pre-examination, will include carefully scrutinising that the project plan causes no adverse impacts on any other part of the network. Meanwhile, strenuous local efforts to get the upgrade to the Girton Interchange back on the agenda have met with some success with HE adding it to the list for consideration in its next round of projects.

The council's budget meeting brought confirmation of the additional funding allocation that I have lobbied for over the recent past. An additional £20m over the next 5 years is a substantial increase in the current year allocation for footpath maintenance [£1.3m]. 50% of this will be spent on surface treatments with the other

50% being allocated for more radical work such as resurfacing and reconstruction. £2.73m additional funding was also approved for measures to prevent flooding and improve local biodiversity. This will include rapid gully clearing at all known risk sites and better verge maintenance on rural roads.

Re-location to New Shire Hall

Development of New Shire Hall at Alconbury Weald has progressed during the year. Planning permission is to be sought for solar canopies to be installed in the car park. These will provide energy both for charging electric vehicles and for the building itself. The design of the building already includes solar panels on the roof to reduce energy usage from the grid, and adding these solar canopies will boost the volume of electricity generated to meet approximately 40 percent of the on-site electricity demand and support clean energy for the electric vehicle chargers. Air source heat pumps will also replace the need for fossil fuel heating on site.

The end of this year also sees the end of the council's current 4 year term. It has been a year of challenges, regrettable delays in progressing some plans, and, above all, very sad losses. It has also been a time that we can reflect on with some pride. It has seen collaborative working between organisations at all levels and has expedited new ways of working. In closing I thank all the parish councils in the division with whom I have very much enjoyed working, the community volunteers who stepped forward so quickly to do very valuable work, and to my hard working district council colleagues. My very best wishes for the future to all of you and to all the residents in the four villages that make up Bar Hill Division. Take care. Stay safe.

Annual report to Parish Council from District Councillor Bunty Waters 2020/21

Over the last year and half the Covid 19 has taken over our lives, however, through Government grants in various ways as in Furlough, Business Grants, Grants for those who need to isolate and cannot work, it has, through these, the country has been able to function, although, sadly, many business' have ceased due to closure of their business'.

Now there is the Roadmap for the easing of lockdown

We now have a roadmap from government for the easing of lockdown. This does bring us hope that we can gradually reclaim some control over our lives. However, we know that the roadmap is dependent on continued progress with infection rates, the number of hospital admissions, as well as the rollout of the vaccination programme.

Across all our services the District Council is working to identify how the roadmap will affect our operational activities and what action we need to take.

SHOP LOCALLY AS THE RETAILERS OPEN THEIR DOORS

Shop locally and support your neighbourhood high street – that's the District Council's call to South Cambridgeshire shoppers as non-essential retailers prepare to open their doors for the first time since lockdown.

As part of its Business Plan priority to grow local businesses and economies, the Council is appealing to consumers to shop closer to home and help their local community and economy to recover from COVID-19.

PLEASE TAKE YOUR LITTER HOME

South Cambridgeshire residents are being urged to ensure they follow social distancing rules when meeting friends outdoors – and take their litter home.

It is an offence to drop litter on land or into water that's accessible to the public even if it's private land. This applies to private land that the public can access, for example a right of way. Offenders can be prosecuted in a magistrates' court and fined up to £2,500. Litter droppers can get a fixed penalty notice of £150.

COMMUNITY SAFETY PARTNERSHIP

The Community Safety Partnership is a partnership between South Cambridgeshire District Council, Cambridgeshire County Council, the Police, Cambridgeshire Fire and Rescue Service, the NHS and the Probation Service, which meets together to tackle local crime and anti-social behaviour. As part of this work, the Community Safety Partnership wants to encourage residents to take ownership of some of these local issues to create local solutions – and there is funding and support available to help you do this. Community Safety Partnership funding Grants of between £50 and £500 are currently available to improve community safety – and the deadline to apply is 1 September 2021. Voluntary groups, charities, parish councils and enthusiastic individuals can apply for funding for anything from the cost of printing leaflets or posters; hosting a website; or to buy equipment for a Speedwatch group, litter picking, or to create a community garden; or to access training, such as on how to tackle local antisocial behaviour. Local people will know best what your local area needs, but funding is available for projects that:

- seek to improve or contribute to community safety
- develop the resilience of the community to crime or antisocial

SOUTH CAMBS COMMUNITY CHEST

The Council has funded the Community Chest scheme since 2011, handing out more than £550,000 in grants to local good causes in that time. As a rolling scheme, there is money available every year for non-profit groups in South Cambridgeshire to fund projects that benefit the district's residents. The deadline to apply for funding for the current year was 31 March 2021, and there is £40,000 still available to eligible groups, which could receive up to £1,000 per project. Even if you don't currently have a group established, it is possible for the funding to be used to cover set up costs for new groups – from training to insurance, and licences to equipment. So if there is a need that you have identified in your community that you would like to meet and would be able to if you had some funding, please contact our team for guidance or apply online before a new deadline. Established groups can also apply for funding, as long as you haven't already received Community Chest funding in the current year. The funding could be used for improvements or repairs to community buildings, to install a local monument, or to provide equipment for sports clubs or community groups, for example. BAR HILL PARISH COUNCIL – CHAIRMAN'S REPORT FOR 2020/2021

A warm welcome to you all for this Annual Parish Meeting for 2020/2021, I am Bunty Waters Chairman of the Parish Council.

Council meetings have been held via zoom which has its challenges but has worked well so that the work of the village continues.

My thanks to all the Parish Cllrs, Geof Tamulonis, Brian Howard, Roger Hall, Darren Scholes, Sue Jenkins, Anthony Mitchell, Khadijeh Zargar, Peter Stockton, and new Cllr, Kevin Potts, they work hard for the village and this is increasing each month, they are unpaid volunteers and give their time, not only for meetings but work around the village.

We have been very sad to lose Councillors this year, I thank them enormously for the contribution for their time as Parish Councillors and their work for the village.

Malcolm Cox, our Responsible Finance Officer, who ensures that the money is spent properly on village matters. and to my Vice Chair, Sue Jenkins, Vice Chair, who gives much support, especially standing in as Chair to the Environment and Amenities. We are also well supported by Kate Flack, our Office Assistant, and our new Clerk, Jennie Cox, who work so hard and guides us Cllrs through the incredible amount of work which this Parish Council has.

I am indeed thankful to have their knowledge to ensure the Parish Council continually is able to work on behalf of village residents. Grateful thanks too, to County Councillor Lynda Harford for her work and advice to the PC throughout the year.

This village requires a great deal of work, you will see a breakdown of how we spend the money throughout the year in the RFO's report on behalf of the village.

Councillors need to meet, at various times, with contractors, so their time is used to discuss the requirements and ensure getting value for money, however, made more difficult in these Covid times.

'Meet the Councillors' - The Council began meetings with the residents and Councillors on the last day of the month at the Parish Council office, these proved very successful as it gave them opportunities to discuss any problems and concerns, sadly, due to Covid 19 these are temporarily stopped, though they will be re-instated when possible.

I am pleased to say that the PC have engaged once again, Haydens, an Arboricultural Consultancy company to help us manage the trees in the village, it is very important to have professional reports so that knowledge of the health and feasibility of the trees is known and documented. This new report will be for the next three years, we hope to have advice on the type of tree that can be beneficially planted in the village and those that are going to be problematic.

The PC deal with a great many tree requests, in fairness trees cannot just be removed, however, when a query/request comes into the PC office it is inspected , discussed at the Environment and Amenities and main Council meeting and action taken if necessary.

As the village ages, built in the sixties on clay, with climate change with the increasing severe weather, there are more problems with subsidence. The Parish Council refer to the insurance company when the Council is informed who will deal with reports from the property concerned.

The Parish Council put in a bid for the Cambs County Council Local Highways Initiative (LHI), for repairs to the pathway from Hanover Close to the village centre, there were too many bids into the County Council and Bar Hill were not successful this time but will keep putting applications forward when they arise.

The A14 Legacy fund for which we put in a very good bid, we understand, will be putting in a pathway from the Village Hall round to the corner of Hanover Close. Disappointingly, the A14 Legacy Fund has not given all that was expected for the village, in discussions with A14 contractors about the pathway, it is probably expected that some additional funds may be required from the Parish Council.

There are also funds to be paid to the Parish Council, from the A14, for land taken and these you can see on the detailed paper from the RFO, the Parish Council are waiting for this to be finalised, at present it is just over 18K and the Parish Council would like suggestions from the residents of Bar Hill as to how this should be spent which would benefit all residents.

The outside of the Parish Council office has been painted, it is important that the upkeep of the office is maintained where possible.

Litter and dog fouling continues to be a problem on the village, even though there are a great many bins in strategic places, thank you to all who do litter picking every day, in these times, sadly, we are finding a lot of broken glass on the play areas, bottles deliberately smashed on play items.

The Parish Council had hoped to have meetings and advice from the CCC Flood Prevention Officer, these have been put back due to Covid 19 and even now still awaited.

Sue Bell, the previous Clerk, put together a very comprehensive Covid19 virus plan and has spent a great deal of time to ensure the safety of herself, all staff and Councillors, the office has been closed to all public. Some staff and Cllrs have been shielding and it is essential that all care has been undertaken.

A Covid 19 support scheme was started in the village by four volunteers in April 2020 and the Parish Council donated £500 to the Scheme.

The Parish Council was successful in applying for a 10k grant from SCDC, through the Government for help to business' and other Covid areas where spend has been higher than expected.

The building work at the hotel site, is on its way, being built by Wellington on behalf of Sanctuary Housing.

Parking continues to be a problem on the village, the PC are always asking that residents park thoughtfully with consideration to others but this is not always the case, however, highways are for the use of vehicles and the PC has no jurisdiction over the roads.

Viking Way was never adopted by Cambridgeshire CC as were the other roads, so is owned by the Parish Council. Work this year has been on clearing the drains which have caused some flooding. Metrorod are in the process of clearing the 40 gullies in Viking Way, most of which have been done.

The PC Website holds a lot of up to date information on not only what the Parish Council does, but areas which are affecting the village, if you have any queries and can't access the website please ask Jennie Cox, our Clerk who will help you.

Web Content Accessibility Guidelines (WCAG)2.1 has a dedicated Councillor who is updating the Councillors, its aim is to ensure public sector websites and mobile apps are accessible to all users, especially those with disabilities.

The PC publish all agendas, accounts monthly on the noticeboard, so residents can access what is happening here in the village, and if you wish to join a meeting to see how the Parish Council work.

Of great sadness is the retirement of our Clerk, Sue Bell, I felt quite panicked when she gave in her notice, as in 'what shall we do' but I do wish her very well for her future and those plans of other things to do. An enormous thanks to her for incredible hard work that she has done whilst in her role as Clerk and how she has helped us as Councillors. Sue has kindly agreed to stay on for a short time while we look for a new Clerk, I really do thank her as she will be incredibly difficult to replace.

My report does not even cover all the work which we undertake but gives a small flavour of a very busy Parish Council.

Environment and Amenities Committee Report 2020/2021

I would like to start by saying thank you to Doris and Mervyn who have sadly left the council this year for their dedication and hard work on this committee. Despite the pandemic we have continued to have meetings but moved online and carried out as many works as possible within Covid rules.

The E&A committee deals with tree works, grass cutting and the stream amongst other green issues. A large amount of the Precept is accounted for within this heading.

The tree works are done twice a year within set periods to comply with the law. We commission an independent specialist tree company to carry out a survey every three years and this forms the basis of our tree works for that period. It is split into categories such as tree health and any potential risk. We then work through that list by meeting with approved specialist contractors and gaining quotes. Over the last two weeks a new tree survey has been carried out, once received this will form the basis of planned works to be carried out over the coming 3 years.

The stream banks were cutback this year as part of planned maintenance. We are currently waiting for a report that has been commissioned by CCC into local streams before embarking on any new works in case it has implications for us.

Grass cutting has resumed and the first 2 cuts have been completed as part of a new contract. The contract was put out for tender this year and invited bids so that we could ensure continuity for the next 3yrs.

There are many other issues that the E&A committee deal with including resident requests. If you have something to report or request could we ask that you use the form on our website or ask the office for assistance, these will be looked at case by case within guidelines and after taking specialist advice if necessary.

It has come to the Parish Council's attention that persons unknown have planted some small trees around the perimeter road. We would like whoever did this to come forward and engage with us so that the species can be identified and planted in a more appropriate place if necessary. We all love trees and it would be a shame to have to remove them to mitigate possible future risk rather than replant where they can be enjoyed for many years to come safely.

Also, we are pleased to announce we have set up a new committee to deal with possible new plantings, when and where appropriate, we have some spaces to welcome residents to join us. We already had an informal meeting and can't wait to get started so please register your interest asap via the office.

We have 5 play equipment sites to maintain and manage. They are visually inspected weekly by an independent inspector, they are also inspected annually by an independent play inspection company to comply with regulations and our insurer's requirements. This year's inspection has been booked for June.

You will notice that some of the equipment has been redecorated recently as part of planned maintenance and some repairs have also taken place due to wear and tear.

Earlier in the year the job of cleaning all the safety surfacing started but for reasons beyond our control the job hasn't been completed as yet but will be very soon hopefully.

Sadly, I have to report money has had to be spent from the precept on mindless acts of vandalism again over this past year. There have also been some incidents of glass bottles being smashed in the main park nearest the primary school recently, potentially endangering children wishing to use the equipment. We will prosecute anybody found to be damaging the equipment or committing any act of vandalism around the village.

We would like to remind residents to adhere to any government social distancing requirements and restrictions due to Covid 19 when using any of the play equipment and that they are responsible for their own and their children's health and safety at all times.

Finally, we would like to thank the residents who can often be spotted around the village voluntarily picking up litter, they are doing a great job keeping the village tidy.

Maple Surgery

MKGP Plus Ltd have now been running Maple Surgery for one year as from 1st April 2020. Like so many others we have experienced a very challenging year facing a global pandemic that has had such an impact on us all.



The team along with our patients embraced the changes that were needed to operate safely and in time the community became used to the new normal.

We would of course have liked to develop things at Maple in such a different way, we had hopes of meeting our patients face to face by holding coffee mornings in the surgery along with carers cafés and group consultations – we hope that these things are not in the too distant future now.

We have however managed to maintain meetings with our Patient Participation Group by holding virtual meetings. Unfortunately over the last few months, due to making provision for staffing to run the roll out of the Covid Vaccination Programme, we have not met but we are reconvening in April and will continue our regular meetings. Feedback from our patients is invaluable in striving to make improvements to the surgery and we are in regular communication with the PPG Chair.

It is fair to say that we have faced unexpected issues in maintaining a regular salaried GP in the Surgery. We are constantly reviewing our clinical model to alleviate the pressures that a single handed GP will face by working with different skill sets such as Advanced Nurse Practitioners and Pharmacists. We are presently working with external agencies to secure salaried GP's and Advanced Nurse Practitioners and in the meantime sessions are being run by regular locums which enables continuity of care for the patients.

We are also very aware that delays in prescriptions has been an historical issue at the surgery. During the last year we have taken steps to undertake medication reviews that were outstanding along with improving the way prescriptions are dealt with at the surgery from how patients order them to introducing a member of the team as our Prescribing Clerk who is supported by our Clinical Lead Pharmacist. We have recruited a further Pharmacist and a Pharmacy Technician who join us in June and this will streamline the process of approving medication and undertaking medication reviews whilst dealing with routine prescription request.

We have been working extremely closely with NHS Property Services who own the building. We have had new flooring laid and are awaiting a full redecoration along with new windows and blinds.

An intercom system has also been installed. This has made access to the surgery far easier as patients can announce their arrival by talking directly to the receptionist who will then allow entry. This has ceased the need for any patients to queue outside whilst awaiting a member of the team to physically come and answer the door.

We introduced a new online triage system to patients called Klinik which is now fully operational and receiving good reviews. It is a system that is available 24 hours a day which allows patients to make contact with the surgery for routine queries, triage etc.

The surgery is part of Cambridge Northern Villages Primary Care Network. This allows us to work directly with 7 other surgeries in the area which enables us to share staff and resources. Our newest members of the network team are a Social Prescriber and First Contact Physio. Both of these staff members will be based at Maple Surgery once a week and the services they provide are explained on our website.

Our nursing team remains the same with our very experienced team. We have also introduced a HCA that is now running further phlebotomy clinics which makes it far more convenient for patients to attend the surgery rather than having to drive out to the Park and Ride at Newmarket Road.

Our administration team remains stable, and we have recruited two new members of the team over the last 6 months who have fitted in really well.

With lock down easing and the Covid vaccination roll out being an immense success we would like to assure our patients that we will continue to strive towards improving our services and look forward to working with the community.

These include children's Sunday activities, small groups (Bible study), Holiday Club, The Olive Tree café, The Art group. However the organisers of these hope to bring them back as soon as guide lines mean it is safe.

A new initiative during this year has been a short daily prayer session on Zoom each week day morning at 8.15. It has a regular attendance of between 10 and 16 people each day and is led by Rev Charles Mather and a couple of volunteers.

Bar Hill Church was involved in the setting up of the Covid-19 support group and also the group that supported the lorry drivers staying at the hotel. Thank you to all who have been involved in these ventures.

It has been a busy year for the Trustees of Bar Hill Church and also for our minister Charles Mather. Many people within the church have worked hard to support our Zoom services with providing music and technical support. There is also a group of people who have provided pastoral support. The Trustees would like to thank everyone who has helped to make this church year possible.
